The venture data will be used for marketing purpose on social media platforms, only upon receiving owner's explicit consent.

The Venture data will be collected through the Application form.

- The photographs taken during the event may be used for our reports, marketing fliers for future events and published on our website and our social media handles (LinkedIn, Instagram, Twitter).
- The legal basis for processing is consent to this statement
- The data will be used exclusively for the purposes described in the statement. Any other use will always be subject to further consent. Your data will not be used for advertising purposes without the owner's explicit consent. However, the right to use pictures taken during the event and some impact metrics (such as number of startups present, mentoring sessions taken place, any outcome from the program like pilots from the industry connect, testimonials from the startups) of the The SUP Challenge Goa, 2022 for social media posts of Climate Collective is reserved. Photographs (screenshots) taken during the event will also be used for the purpose(s) mentioned above.
- The Climate Collective uses appropriate technical and organisational measures to secure data against unintentional or intentional falsification, destruction, loss, or access

by unauthorised persons. Access to your personal data is restricted to The Climate Collective staff, running the The SUP Challenge – Goa, 2022, who need to process it for the above- mentioned purpose(s), and who will handle the information you provide in a proper and confidential manner.

- Your information will not be sold to third parties like data brokers. We will be using your data only on Accelerator App and Mobilize that help us run programs, having similar data privacy policy.
- Cookies are small text files that are saved locally in the cache of the user's internet browser. We use them for the duration of a session for the purpose of identifying users when they log in, selecting the correct menu language and ensuring smooth operation.
 Cookies can be deactivated in the browser. However, this may have a detrimental effect on the functionality of the application.

Rights of data subjects

You are entitled to enquire about your personal data and also the data related or submitted in the application form, have the data corrected if necessary, and ask for processing to be restricted or data to be erased. The data will then be removed from our system. The consent given to use personal data can also be revoked at any time. This does not affect the lawfulness of processing up to the time of revocation. The IP (Intellectual Property) related to the innovation stays with the applicant and is not transferred.
